<b>Arizona Revised Statutes §39-121.03 defines commercial use as:</b>  “The use of public record for the purpose of sale or resale or for the purpose of producing a document containing all or part of the copy, printout or photograph for sale or the obtaining of names and addresses from such public records for the purpose of solicitation or the sale of such names and addresses to another for the purpose of solicitation or for any purpose in which the purchaser can reasonably anticipate the receipt of monetary gain from the direct or indirect use of such public record. Commercial purposes do not mean the use of a public record as evidence or as research for evidence in an action in a judicial or quasi-judicial body of this state or a political subdivision of this state.”		(Non-commercial requests are billed according to cost of time, equipment & personnel used in making the copies, but not the cost for searching the records.)
